

General Terms and Conditions Camping Winkl-Landthal GmbH as of 2025

Reservation (from 3 nights)

A seat reservation is only binding if the deposit is paid by bank transfer or PayPal within 3 days. The deposit depends on the length of the stay and is to be paid per place.

3-5 nights € 80.00 deposit 6-8 nights € 100.00 deposit per additional week or part thereof additional € 100.00 deposit

With the binding reservation and payment of a deposit, a contract is concluded between the guest and the campsite operator.

Group reservations are only accepted with advance payment of the total amount for the specified number of people.

The full invoice amount for the reservation, minus the deposit already paid, is due upon arrival.

The booked place will be reserved for you on the day of arrival and for the booked time. If no arrival takes place during opening hours without feedback or further notification, this releases the campsite operator from his contract.

There is no entitlement to specific seats. It is up to the site operator to decide which place is allocated. The seat requests from the contact form will be taken into account for early bookings.

The current price list is valid for booking until a new price list is issued.

Arrival and departure

Arrival is from 2.00 p.m. to 6.00 p.m.

An early arrival in the morning will be charged with an additional 20€.

Departure: Please vacate the pitch by 11.00 a.m.

A later departure after 11.00 a.m. will be charged with an additional night's stay.

Electricity will be charged on departure according to actual consumption.

There is a one-time connection fee of €2.50 per connection.

Cancellation, cancellation or cancellation of the reservation

In case of cancellation up to 21 days before the day of arrival, the deposit / payment will be refunded.

After the 21 days, there is no refund of the deposit. Remaining amounts with full payment in advance will be refunded.

There will be no refund if the reservation is not kept, i.e. if you do not show up on the day of arrival.

In case of early departure, there will be no refund of the unused days. The tourist tax of the unused days will be refunded.

In case of cancellation of a group, after the cancellation period no refund of the payment.

In case of cancellation of individual persons from a group, after the cancellation period no refund of their accommodation fees.

If you are unable to arrive after the cancellation period due to illness of any kind, our terms and conditions apply.

We recommend that you take out travel cancellation insurance of your choice or the link to the Ergo insurance on our homepage.

General

All persons who are not registered by name in the contract must be registered as visitors. The respective visitor fee can be found in the price list.

For caravans, tents or campers that are parked uninhabited during the stay, the normal daily fee for the registered persons + pitch fee will continue to be charged.

For single occupancy of a pitch in high season with only 1 person, a surcharge of 6.00€ per night will be charged.

Means of payment: cash, or from 50.-€ with EC card, or credit card.
